1. Tribhuwan International Airport Civil Aviation Office (TIACAO) invites sealed bids from eligible and qualified bidders for the Supply and Delivery of Rescue and Fire Fighting Equipments and Accessories (Re-Invitation)

Bidding documents may be purchased on or before 2071-03-11 (25th June 2014) from the above office of Procurement Section, Tribhuwan International Airport Civil Aviation Office and the office of Civil Aviation Authority of Nepal, Head Office, Store Section, by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of Nepali Rupees 3000.00 (without VAT) in cash or in form of bank receipt for fee deposited in Account Number 58 or of US\$ 35 (without VAT) in cash or in form of bank receipt for fee deposited in Account Number 30 K at Rastriya Banijya Bank, TIA Branch, Gauchar, Kathmandu or in the form of bank draft in favor of the Tribhuwan International Airport Civil Aviation Office. If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional fee of NRs. 5000.00 or US\$ 60. (Without VAT) However, the Purchaser will not be responsible for delay or non-delivery of the documents so sent.
4. Pre-bid meeting shall be held at 13.00 LT on the 2071-02-25 (8th June 2014) at TIACAO. If a pre-bid meeting is held, attendance is strongly advised for all prospective Bidders or their representatives but is not mandatory.
5. Sealed Bids must be submitted to the above office Tribhuwan International Airport Civil Aviation Office on or before 12:00 on 2071-03-12 (26th June 2014). Documents received after this deadline will not be accepted.
6. Bids shall be opened in the presence of Bidders or Bidder's representatives who choose to attend 14:00 on the 2071-03-12 (26th June 2014). at the office of Procurement Section, Tribhuwan International Airport Civil Aviation Office, Gauchar, Kathmandu. Bids shall be opened even in the absence of the bidders or their Authorized representative(s). Bid must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a NRs. 2,81,000/- (Two lakhs eighty-one Thousand) or of US\$ 2850.00 which shall be valid for minimum 30 days beyond the bid validity period.
7. In the comparison of Bids, Domestic Preference Scheme will be applied in accordance with the provisions stipulated in the instruction to Bidders.
8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
9. The Purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
10. Partial Bid offer will not be entertained.

All the certificates shall be attested by Notary Public Attestation shall be in English Language.
